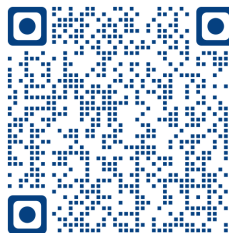
Advice & Aid will accept and process KS State Tax Credit Applications (Form K-96) for gifts of \$250 and greater.

Example Donations and Credits

Donation You Make to Advice & Aid	\$10,000	\$5,000	\$1,000	\$250
Your Kansas State Income Tax Credit	\$7,000	\$3,500	\$700	\$175
Your Out-of-Pocket Cost	\$3,000	\$1,500	\$300	\$75

WHY DO YOU WANT A CREDIT?

Tax Credits are NOT deductions. Deductions reduce your total income before taxes owed are calculated.

Tax Credits directly reduce the amount of tax you owe. This means **tax credits have a much greater impact on your Kansas taxes and can be a huge benefit to you.**

HOW THE TAX CREDIT WORKS

1. Advice & Aid will provide you a Tax Credit Application KS form K-96 (on the back of this insert).
2. Fill out the Application and send it to Advice & Aid with your donation.
3. Donate \$250 or more to Advice & Aid Pregnancy Center anytime after 7/1/2024.
4. Advice & Aid will submit the Application to the State on your behalf.
5. The State will process your Application.
6. Upon approval, Advice & Aid will mail you all necessary documentation for your tax filing.

The Small Print—Things You Need to Know

- Advice & Aid will accept and process KS PRA Contributor Applications (Form K-96) and donations for gifts of \$250 and greater.
- Complete the form and mail the original to PO Box 7123, Shawnee Mission, KS 66207. Copies will not be processed. While the form does not ask for your Spouse's SSN, it is required for us to file for your credit.
- Donation must be made by cash, check, or credit/debit card.
- To be eligible, pledges must be fulfilled within 90 days or by the end of the year, whichever comes first.
- Donations from DAFs, foundations and QCDs are not eligible for this tax credit.
- Tax credits totaling \$10M can be approved by the KS Dept. of Revenue. Once that maximum is reached, no further credits will be approved by the state for the year. Advice & Aid cannot assure that your application will be approved.
- Discuss this opportunity with your tax accountant to determine what is best for your personal taxes.
